Dr. Olson discussed the following items:



The Dental Assisting Program at Daytona State College will soon call on your practice to accept students during the externship/internship program. **The dentists' participation and expertise is a key component during the development of competent skilled and knowledgeable dental assistants.** For students to gain a diverse clinical experience more dentists are needed to participate with the externship program. Due to the number of dentists participating compared to the number of students, an appeal is being made to encourage dentists to activate a contract with the Dental Assisting Program. Please have your office contact Leslie FehI, Program Manager at Daytona State College for additional information. The contractual process is time sensitive, so please contact Leslie very soon.

January through April: student is placed for two (2) days a week (Tuesday and Thursday).

May through June: student is placed for two to four (2-4) days a week (Monday through Thursday).

Externship periods are from January to June; this does not mean every dentist will have a student placed during these times. There are several deciding factors influencing who, when, and where to place a student which makes the number of dentist that participates so important.
