Executive Board Meeting Minutes

The Volusia-Flagler Dental Association Executive Committee convened at 5:40 pm.

Points of Discussion

I. Approval of meeting minutes from August meeting - The minutes were dispersed and reviewed. Dr. Borer motioned to approve the minutes, it was seconded by Dr. Bergens. The motion carried.

II. Treasurer's Report – Dr. MacIntyre dispersed the financial report.

A. The Executive Board decided not to publish the financial reports in the Newsletter since the Newsletter can be publically accessed on the VFCDA website. Only members are privy to specific financial information

B. Dr. MacIntyre explained that the online payments are effective. Most members have used the system without difficulty.

C. Dr. Pranikoff mentioned that the FDA has successfully recruited members by mailing notices to the home addresses of constituents. Dr. MacIntyre has taken this suggestion under advisement. He will consider mailing out notices in a few months if membership renewals are low.

D. Dr. Borer made a motion to accept the report, which was seconded by Dr. Kometas. The motion carried.

III. Old Business:

A. Speakers– Dr. Patel reported on the speakers that he is trying to obtain for our meetings. He has contacted Hiossen Dental Implants about sponsoring the speaker for the October meeting. Other potential future speakers include ER physicians and practice transition consultants.

B. Delegate Announcement: Dr. Borer announced the delegates. The new delegates are Dr. Brian Bergens, Dr. Scott Lawson, and Dr. Roderick MacIntyre. The alternate delegates are Dr. Jason Larkin, Dr. Sandeep Patel, and Dr. Dusanka Angelov.

III. New Business:

A. Future Meetings– Discussion ensued regarding the possibility of eliminating the March meeting. Dr. Patel suggested uniting with the Brevard County Dental Association for a joint all-day meeting in February. He will inform the Board about any further developments on this idea.

V. Adjournment – Dr. Borer motioned to adjourn the meeting, and Dr. Sandeep Patel seconded the motion. The motion carried and the meeting was adjourned at 6:35 p.m.
