Executive Board Meeting Minutes

The Volusia-Flagler Dental Association Executive Committee convened at 5:50 pm.

Points of Discussion

- I. **Approval of meeting minutes from December meeting -** The minutes were dispersed and reviewed. Dr. Patel motioned to approve the minutes, and it was seconded by Dr. Kenzik. The motion carried.
- II. **Treasurer's Report –** Dr. MacIntyre dispersed the financial report. Garrett Klayer submitted our 990 form for the dental society. This form is submitted for non-profits and must be submitted by January 15th. Discussion ensued regarding our balance. The PNC Sponsorship should pay this January. Dr. Kometas motioned to approve the financial report, seconded by Dr. Kenzik. The motion carried.
- III. **Old Business:**
 - A. **Sponsors-** PNC will pay \$5,000 in January for 2016.
 - B. **Speakers–** Dr. Patel is arranging for a physician to speak at the April meeting.
 - C. **Installation Banquet Update–** Dr. Borer will take care of the menu at Oceanside Country Club.
 - D. **Joint Full Day February Meeting-** In lieu of a February meeting, the VFCDA will join the Brevard County Dental Association for an all-day meeting on February 19, 2016. Our October speaker, Dr. Hyung-Jun Kong will address Brevard County at their monthly evening meeting on February 18, 2016. All interested VFCDA members are both invited and encouraged to attend.
 - E. **Dues Update:** Dr. MacIntyre will acquire the Square D device to accept credit cards for dues payments.
- III. **New Business:**
 - A. **Budget–** Dr. Patel and Dr. MacIntyre will meet in March to complete the budget.
 - B. **HOD Caucus and Meeting-** The House of Delegates Caucus is 14 January 2016. The HOD Meeting is on 22 January 2016 and 23 January 2016. Dr. Angelov, Dr. MacIntyre, Dr. Pranikoff, and Dr. Bergens will attend.
 - C. **Brown Tooth Society Fundraiser–** The Brown Tooth Society is scheduled for 7 January 2016. This is an ADA Foundation Fundraiser with a surprise location each year.
 - D. **Officers and Delegates for 2016–** The Committee has proposed Dr. Roger Thayer for Treasurer. Dr. Brian Hamilton has expressed interest in being a delegate.
 - E. **LPGA Update–** Dr. Patel mentioned that the room and AV rental fees have been waived. He presented preliminary fees, and food costs are much lower. Dr. MacIntyre motioned to move the monthly meeting location to LPGA for next year's meetings, which was seconded by Dr. Patel. The motion carried.
 - F. **Flagler County Fluoridation–** Roger Snyder, from the Department of Health, is working to introduce fluoride into Flagler County water. If any members are interested in helping, they are encouraged to contact him directly.
 - G. **Give Kids a Smile–** Dr. Larkin needs volunteers to sign up for Give Kids a Smile on 5 February 2016.
 - H. **Dentist Day on the Hill–** Dentist Day on the Hill is on 2 February 2016. Since Dr. Manne cannot attend, all interested parties must arrange their own transportation.
